Protecting your private information is our priority. This Statement of Privacy applies to MusicWorks and <a href="www.MusicWorksWonders.org">www.MusicWorksWonders.org</a> and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to MusicWorks include <a href="www.MusicWorksWonders.org">www.MusicWorksWonders.org</a>. The MusicWorks website (the "Site") is a news and information site. By using the MusicWorks website, you consent to the data practices described in this statement.

## **Collection of your Personal Information**

In order to better provide you with products and services offered on our Site, MusicWorks may collect personally identifiable information, such as your:

We do not collect any personal information about you unless you voluntarily provide it to us. #### **Sharing Information with Third Parties**

All such third parties are prohibited from using your personal information except to provide these services to MusicWorks, and they are required to maintain the confidentiality of your information.

# **Automatically Collected Information**

- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act:
- Enable sole internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.

#### **Children Under Thirteen**

MusicWorks does not knowingly collect personally identifiable information from children under the age of thirteen through our Site. If you are under the age of thirteen, you must ask your parent or guardian for permission to use this Site.
